1. The Stallion Fee is \$750, including a nonrefundable Booking Fee of \$150 which shall be payable upon execution of this contract. The balance of the Stallion Fee shall be payable before semen is shipped.
2. The mare owner agrees to pay a Collection/Processing/Shipping Charge of \$150 for each shipment of semen requested. Additional charge of \$100 for Counter-to-Counter air shipment. Fees must be paid before semen is shipped.
3. We recommend Veterinary reproductive exam and normal uterine culture or cytology before ordering semen for your mare.
4. This contract contains a "Live Foal Guarantee." A live foal is described as a newborn foal which stands and nurses without assistance. If the foal does not stand and nurse, return privileges shall apply only if we are notified (3) days thereof and receive a veterinarian's statement confirming death. There will be a \$250 re-breed service charge. This is non-assignable.
5. A Breeders Certificate will be issued for the foal conceived by the mating when we have been notified that a live foal has been produced and when all fees are paid in full.
6. A photocopy of both sides of the registration papers on your mare must

accompany this contract. The owner recorded on the registration certificate will be recorded on the stallion breeding report.

7. Mare Owner's veterinarian must request semen as early as possible, but by no later than 2:00PM Central Time prior to the day of collection. Any requests not called in by 2:00PM Central Time prior to the day of collection, or cancelled on the day of collection, are subject to a \$50 charge.
8. This contract is governed by, constructed and enforced under the laws of the State of Oklahoma.
